1) Eligibility criteria for participation in the tender:-

- 1.1) The Bids shall be submitted by the OEM / authorized partner of OEM. In case, the bid is not directly quoted by the OEM, the bidder has to submit 'Authorization' / distributorship Certificate in the letterhead of OEM for quoting their item, and mentioning that support towards integration of the quoted item in the circuitry, and after sales service support shall be provided by the bidder during the tenure of warranty period jointly with OEM.
- 1.2) Complete Technical details of the quoted Module is to be submitted as a proof of compliance covering (1) Technical write up of the Module, (2) Country of Origin Certificate, (3) Performance Test Result Sheet.
- 1.3) Item Quoted must be with 2 years comprehensive manufacturer's warranty. Bidders should produce a certificate from the OEMs regarding their acceptance of rendering service, and shall provide fresh Module at free of Cost against replacement of defective part(s) reported during the period of warranty, and shall extend to continue service support beyond the period of warranty by maintaining relevant stock of Module(s) at their premises.

- 1.4) If the bidder was a supplier to Webel Mediatronics Limited in the past, they will be required to give a declaration in their letterhead that they have successfully & timely completed earlier orders of WML offered on them. Relevant details like scan copy of earlier P.O. placed on the Bidder are to be submitted.
- 1.5) Bid validity period: Bid shall remain valid for **30 days** from the date of opening of Bids.
- 1.6) Delivery Schedule: The Bidder shall have to comply with delivery of entire lot of the quoted Module within 4 weeks from the date of award of contract. In case, if any ready stock of the said Module is available, please mention the quantity in stock.
- 1.7) The Bidder shall be required to give a declaration in their letter head that they have not been banned or blacklisted by any Government Agencies / Govt. Department / Quasi Govt. Dept / PSU / Board / Council or similar organization. If any Government Agencies / Govt. Department / Quasi Govt. Dept / Public Sector Undertaking / Board / Council or similar organization banned or blacklisted the Bidder in the past, this fact must be clearly stated.
- 1.8) Copies of suitable documents like Purchase Orders, etc. for verification of the order values and work completion / customer satisfaction certificates (or similar documents) from respective customers against delivery of Modules are to be submitted as evidences for verifying successful completion and execution of the orders.
- 1.9) The bidder shall furnish Annual Report and Bank Solvency Certificate to substantiate they have financial capability to perform the contract. The bidder shall furnish documentary evidence about technical and production capability necessary to perform the contract.
