Interested bidders / suppliers are requested to submit / send their sealed quotation for “**Supply of Fire Extinguishers**” for use by different BL&LR Offices of West Bengal”.

- Tentative quantity of requirement: 200 nos. (Four no. for each site). Delivery should be made in batches as per schedule given by project team / end customer. Entire delivery should be made by mid of January 2016.
- However the above estimate can be increased or decrease as per actual situation / readiness of site etc, managed and controlled by our end customers. This is also to be noted that the procured fire Extinguishers are to be installed and commissioned at 50 sites covering 11 districts of West Bengal namely Nadia, Burdwan, Purba Medinipur, Murshidabad, Dakhin 24 Pargana, Uttar 24 Pargana, Howrah, Hoogly, Malda, Uttar Dinajpur.
- Warranty: Five years replacement warranty (on-site) against defects / operational complaint received from site / BL&LR Officials.
- Payment Terms: Pro-rata Payment will be made on back-to-back basis, after successful installation of fire extinguisher(s) at site and on receipt of our corresponding payment from the end customer against the above said work.

Eligibility Criteria:

- The bidder should have successfully executed supply of fire extinguishers of same make, and type at least 25 site(s) in total during the last three financial years.
- Authorization letter is to be submitted in the letterhead of OEM stating that the bidder can quote their product and necessary service support on their behalf.
- Job completion certificate / copy of Invoice(s) is to be submitted as a part of your quotation as evidence, and in case, the bidder executed similar work at any Govt. Sector, supporting documents is to be attached along with your quotation.
- Company details (PAN / Service Registration etc.) are to be submitted along with your offer.
- Bidder should have at least one registered service center / office within West Bengal (preferably at Kolkata) for smooth execution of above said work..
